Member Spotlight

Kappa Gamma Pi's motto is "Faith and Service." I was asked to write about my recent service, volunteer talks to nonprofit organizations. I am a professional writer, editor, and linguist, and I have picked up a lot of knowledge over my career. I try to share what I know with people who can take advantage of it. Here is a recap of three such talks I have given in the last year

The International Association for Forensic and Legal Linguistics (IAFLL) is a professional organization for students and practitioners who are interested in the intersection of language and law. In 2023, I learned about a research paper with the intriguing title, "Poor Writing, not specialized concepts, drives processing dif-

ficulty in legal language." Another research paper I was familiar with, from decades ago, said something similar about jury instructions, a specific type of legal language. I decided to draw from both of them for that year's IAFLL conference (held at a Catholic university in the Philippines), and gave a talk called

There are so many awesome things to see and do in Indy that we will be hard-pressed to prioritize them. Here's a bit of information about some of the top choices.

Indianapolis Museum of Art at Newfields

The Indianapolis Museum of Art (IMA) is one of the largest and oldest art museums in the United States. IMA traces its roots to the Art Association of Indianapolis, which was founded in 1883. The museum is approximately three miles north of downtown Indianapolis. Its 152-acre Newfields campus also includes the Lilly House, the Virginia B. Fairbanks Art & Nature Park, eight gardens, and four performance spaces. IMA's permanent collection comprises more than 54,000 works including African, American, Asian, and European pieces. Significant areas of the collection include Neo-Impressionist paintings; Japanese paintings of the Edo period; Chinese ceramics and bronzes; paintings, sculptures, and prints by Paul Gauguin and the Pont-Aven School; a large number of works

by J.M.W. Turner; and a growing contemporary art and design collection.

Indianapolis Zoo and White River Gardens

Located in White River State Park, the Indianapolis Zoo is accredited as a zoo, aquarium, and botanical garden. Originally a separate facility that was a collaboration between the Indianapolis Zoo and the White River State Park, the White River Gardens is now part of the Zoo's entrance that creates a total immersion into nature from a guest's first steps inside the Zoo. This beautiful 3.3-acre landmark attraction includes the Hilbert Conservatory, a 5,000-square-foot tropical oasis inside a glistening glass building, as well as the outdoor DeHaan Tiergarten that combines gardening ideas, plant information, and inspirational design to connect animals, plants, and people.

Eiteljorg Museum of American Indians and Western Art

The only museum of its kind in the Midwest, the Eiteljorg Museum houses a diverse collection of visual art by indigenous peoples of the Americas and Western American art.

James Whitcomb Riley Museum Home & Visitor Center

One of the only preservations of a 19th-century residence in the entire country, this National Historic Landmark offers visitors a chance to step through the front door and back in time. Built in 1872, the Italianate style home at 528 Lockerbie Street, Indianapolis, features original Victorian art and furnishings, as well as many artifacts that belonged to James Whitcomb Riley, a writer who became a national celebrity through his poetry about Indiana, nature, and childhood.§

Announcing Our 2024 Cornaro Scholars!

The Cornaro Scholarship is a prestigious scholarship only available to Kappa members for use toward graduate expenses at an accredited university. The Cornaro Scholarship Committee selected two recipients this year: **Richard James Rommeney Jr.** (Saint Joseph's University, NY, '24) and **Hailey Shuman** (Fontbonne University, MO, '24).

2024 Cornaro Scholar Richard James Rommeney Jr. earned a bachelor of science degree in biology from Saint Joseph's University where he graduated summa cum laude. During his undergraduate studies he received many awards including Dean's List, Honors Program, and was inducted into Kappa Gamma Pi, Beta Beta Beta (Tri-Beta) Biological, Sigma Iota Chi, Delta Epsilon Sigma, Kappa Delta Pi Education, and Gamma Sigma Epsilon Chemistry Honor Societies. He will be completing his studies for a Masters of Arts in Special Education with an Annotation in Severe and Multiple Disabilities.

During college, Richard was heavily involved in the clubs and organiza-

tions at Saint Joseph's University which have shaped him into the leader he is today. In his first semester he became the vice president of the Science Club and eventually became the president. He helped to organize engaging club meetings, ensure member participation, and represented the club at various university events. He led health-related initiatives to foster a community committed to scientific exploration and wellness awareness. Richard also served as a tour guide which gave him the opportunity to share his love for the university and its Catholic tradition to prospective students. KGP Lecture Series Recap: Creating an Advance Directive

"Yeah, I'll Do It Some Day" - What if I cannot communicate my wishes regarding medical treatment as I near life's end? Who do I want to make these decision for me, if I cannot any longer express them?

On September 25, this presentation by Dr. Dolores L. Christie (*Ohio Dominican University, OH, '59*) considered many questions surrounding end-of-life needs and the construction of Advance Directives, including Catholic teaching on these issues.

Dee Christie was nominated to Kappa from Ohio Dominican University, where she completed a bachelor of arts degree in biology. Now a retired bioethicist, Dee is the former executive director of the Catholic Theological Society of America, a past president of the Cleveland Chapter of KGP, and past president of the Institute for Learning in Retirement East. She has served on boards of the Jesuit Retreat

"Making Contract Language More Comprehensible."

The second talk "Designing a Presentation: Choosing the Right Tools for Effective Communication" was delivered to Kappa Gamma Pi members via Zoom in January 2024, and is still available via YouTube here https:// www.youtube.com/watch?app=desktop&v=tkKNY-<u>VvldYM&feature=youtu.be</u>. I have seen many, many standup presentations in professional, business, and academic contexts, and I observed what made some more effective than others. I also know about how information can be presented, and how the brain takes it in. I realized that one important part of delivering a presentation was choosing the right medium for each idea the speaker wants to get across. My own innovation was analyzing the available information channels (voice, slides, etc.) in terms of their flexibility, ephemerality, and information density, and using those criteria to determine which channel is most appropriate for each idea or example to be communicated.

In June 2024 I gave an online talk to my chapter of the Society for Technical Communication. Every writer should have at least a basic understanding of copyright law, so they can stay out of trouble. The talk explained the basics of copyright law, including the recent changes with the introduction of generative AI (like ChatGPT). I was able to use examples from my own career as illustrations.

I am a longtime member of each of these organizations. I was happy to do my small part to help them continue to carry out their missions. §
