## Sightseeing in Indy: Lilly House Tour

On Friday, July 18, Kappas attending the 2025 Convention will have an opportunity to tour the Lilly House in Indianapolis, followed by dinner at the Saint Joseph Brewery and Public House.

Kappas will enjoy a guided tour of Lilly House, a National Historic Landmark and exemplary example of a 20th century country estate. Then they will be free to wander and explore the gardens surrounding the house on their own.

The Landon family founded the estate in 1907, building their French-inspired home, greenhouses, and other support buildings. In the 1920s, Jessie Landon invited the Olmsted Brothers to design a garden land-scape to match the grandeur of their home. The Lilly family purchased the property in 1932 and acquired the neighboring properties over the next few decades. They would eventually donate the 56 acres to the Art Association of Indianapolis to build an art museum. The entire 152-acre campus surrounding the house and museum is now known as Newfields.

Today, the first floor of Lilly House has been restored to closely resemble its appearance in the 1930s. In fact, the majority of the furnishings and decorative arts objects on display belonged to the Lillys and were used in the home. The upper level of the Lilly House hosts a variety of events and public programs and offers an expansive view of the Oldfields' landscape and gardens. The garage features an early 20th century-era car on loan from the Indianapolis Motor Speedway Museum.

The newly reimagined lower level of the Lilly House invites guests to explore the stories that make the 26-acre Oldfields Estate the historic heart of Newfields. Richly illustrated with historic and contemporary photographs, the new orientation space guides guests through an exploration of the evolution of the estate and the different people who lived and worked in the house and gardens, as well as key designers who created the landscape guests can enjoy on their visit. A new, hands-on activity encourages guests to try their hand at designing the estate.

Two Kappas will speak during the Convention program on Saturday, July 19, about their commitment to service and the ways their experiences in volunteer roles and public service have yielded personal rewards.

The Joy of Service Kate Coulihan Ficke (Dominican University, IL, BA '75, MBA '83), KGP Recording Secretary

Like mother, daughter. like A 1936 Kappa Rosary from College in River Forest, Illinois (which in 1997 became Dominican University) not only did volunteer work and pursued a full career in

the nonprofit sector but who also devoted the last 20 years of her life to service as a member of a religious order in Los Angeles-Sr. Lucille Z. Coulihan, IHM. Her daughter Kate followed in her footsteps with graduation from Rosary College and nomination to Kappa. (Side note: We at Kappa are thankful that Kate found a way to pressure Rosary College to re-instate its lapsed affiliation with Kappa Gamma Pi, but that's another story).

And then another life of service. In June, Dominican University will present Kate with the O'Keefe Outstanding Volunteer Achievement Award at her upcoming 50th Anniversary Reunion.

Growing up in New York City, Kate started her volunteer efforts early as a pre-teen Girl Scout helping at the organization's NYC Headquarters collating, folding and stuffing various mailings while her mother worked there in a professional capacity. From then to now, it's been a long and winding road to the University Award, involving not only Scouting but a myriad of other groups and organizations that span the country as well as the decades.

Little did Kate know that through her membership

in one of these groups she would meet her "former farmer" husband - an Air Force veteran - and end up in a partnership resulting in numerous opportunities for various service roles in their local and wider communities in the Chicago metro area over the past

44 years. Somehow, Kate (and Jim) managed to find ways to help others - and have fun doing it - no matter where they went.

#### Advocating for the Human Spirit

Luonna is the Indiana State Opioid Response Outreach Manager for the Division of Mental Health and Addiction. Having received her Master of Science in healthcare administration and Bachelor of Science in psychology from St. Mary-of-the-Woods College (SMWC), her lived experiences and passion for public health have laid the foundation for her desire to work within the state's Family and Social Services Administration.

Along with providing public health advocacy for Hoosiers, Luonna's compassion for veterans and their families is reflected through her work as a trained facilitator for the National Alliance on Mental Illness' (NAMI) Homefront courses in addition to serving on St. Mary-of-the-Woods College Alumni Board. Luonna will briefly share her life journey, where she is now, and why she feels compelled to advocate for a person's human spirit.

# Friday evening in Indy: Dinner at the Saint Joseph Brewery and Public House

After touring the Lilly House and exploring Newfields, Kappas will enjoy dinner at the Saint Joseph Brewery and Public House located in the deconsecrated Catholic church in downtown Indianapolis.

Saint Joseph Brewery and Public House was established in 2015, but the building it occupies has quite a history. To meet the demands of the growing population in the northeast section of Indianapolis, the Catholic Archdiocese of Indianapolis, led by Bishop St. Palais, established the parish of St. Joseph in 1873, at that time the fourth Catholic parish in Indianapolis.

Father Joseph Petit was appointed the first pastor of the new parish. A two-story brick structure was built at the corner of Vermont and Liberty Streets (now Park Ave.) the top floor served as the parish church. Father Petit was replaced as pastor in 1874. Bishop Silas Chatard was determined to establish a hospital in Indianapolis and the structure at Vermont and Liberty seemed ideal for this purpose. He purchased two lots on the corner of North and Noble Streets (now College Ave.) and urged the congregation to build a church on the site. The cornerstone of the church was laid on July 20, 1879. The church was designed by architect Diedrich A. Bohlen of Hamburg, Germany and was finished in less than a year. On July 4, 1880, Bishop Chatard blessed the church and Father Petit returned to celebrate the first Mass.

Father Francis B. Dowd was named pastor in August of 1900. Four new parishes established between 1881

and 1909 cut into the original boundaries of St. Joseph with homes in the area being replaced with industrial factories and mills. Father James Jansen was named to succeed Father Dowd in 1942, but the decrease in membership led to the decision to close and deconsecrate the church. The last Mass at St. Joseph church was said on June 26, 1949.

The church building, still owned by the Archdiocese of Indianapolis, was then converted to the Catholic Community Center, to be used as a meeting hall and auditorium for several organizations including the Catholic Charities Bureau and Catholic Youth Organization. This use continued into the 1970s until those organizations moved out and the building was used for storage. After many years of disuse, the building fell into disrepair until the massive renovation occurred in the 2010s, allowing the building to be repurposed as the restaurant and brewery which we see there today.

# A Visit to the Racing Capital of the World

No visit to Indy would be complete without a trip to the Indianapolis Motor Speedway!

The Indianapolis Motor Speedway (IMS) is one of the oldest and most revered motorsports facilities in the world. Since its construction in 1909, this famous 2.5-mile racetrack has become a National Historic Landmark and a legend in the world of auto racing.

Known as the Racing Capital of the World, the IMS just completed a \$60.5 million, 17 month renovation and on Sunday, July 20, Kappas visiting Indianapolis for the Convention will have an opportunity to visit the Museum. Featuring more than a century of motorsports history, this museum's engaging and educational exhibits bring the thrill of the Indianapolis 500 and the Indianapolis Motor Speedway to life.

In addition to visiting the Indianapolis Motor Speedway Museum, guests can opt to do the Victory Po-

dium Tour. This 30-minute tour shows you what the winner sees on Race Day. The tour features a trip through the Garage Area and famed "Gasoline Alley" with a final stop at the top of Victory Podium - where the Indianapolis 500 winner celebrates their triumph with the customary bottle of milk.

# Resolutions Proposed for 2025 Convention

The delegates assembled at the Kappa Gamma Pi National Convention will process resolutions during the business meeting on July 18, 2025. Resolutions that include proposed changes to the Constitution and By Laws are required by Article IX to be posted at least 60 days before the start of the convention. Delegates will discuss and vote on three such changes that include adding a method for determining possible dissolution of the organization, modifying the size of convention committees, and omitting the stated dollar amounts of annual dues and nomination fees.

If you plan to attend the convention, please consider participating on a convention committee. It involves about an hour of time to attend a committee meeting Thursday afternoon before Friday's business meeting. If you would like join a convention committee, please contact the National Office.

#### Resolution 1 - Dissolution Based on Convention Registration

Whereas Kappa Gamma Pi has in recent years experienced low attendance at conventions, a decline in dues support from members, a reduction in the number of active chapters, difficulty recruiting members to serve on the National Board, the closure of multiple affiliated colleges and universities, and fewer nominations of new members from the remaining affiliates, therefore be it resolved that the following language to be added to the KGP Constitution, following the current text of Article XI - Dissolution as a separate section: "If fewer than ten delegates, not including National Board members, are registered for a National Convention sixty (60) days before the Convention begins, the event shall be canceled, and Kappa National shall be dissolved on July 1 of the following year. Any assets remaining on that date shall be handled as described above."

#### Article XI - Dissolution

#### **Current Verbiage**

# If the National Board by a simple majority, decide at any time, on grounds of expense or otherwise, that it is necessary or advisable to dissolve the Organization, it shall call a Special Convention of the Organization. The National Office shall provide all current dues paying members written notice of the Special Convention and include the date, location, and time of the Meeting at least thirty (30) days in advance of the meeting date. Dissolution shall require a two-thirds vote. The National Board may also submit a Convention Resolution to the delegates assembled at a Biennial Convention if less than three Local Chapters remain active.

Any assets remaining after the satisfaction of any proper debts and liabilities, shall be given or transferred to any charitable organization with similar aims and objectives to Kappa Gamma Pi as determined by the delegates at the Special Convention or Biennial Convention.

## Proposed Amendment

#### Section 1. Dissolution by Vote of the National Board

If the National Board by a simple majority decide at any time, on grounds of expense or otherwise, that it is necessary or advisable to dissolve the Organization, it shall call a Special Convention of the Organization. The National Office shall provide all current dues-paying members written notice of the Special Convention and include the date, location, and time of the Meeting at least thirty (30) days in advance of the meeting date. Dissolution shall require a two-thirds vote. The National Board may also submit a Convention Resolution to the delegates assembled at a Biennial Convention if less than three Local Chapters remain active.

Any assets remaining after the satisfaction of any proper debts and liabilities shall be given or transferred to any charitable organization with similar aims and objectives to Kappa Gamma Pi as determined by the delegates at the Special Convention or Biennial Convention.

# **Section 2. Dissolution Based on Convention Registra-tion**

If fewer than ten delegates, not including National Board members, are registered for a National Convention sixty (60) days before the Convention begins, the event shall be canceled, and Kappa National shall be dissolved on July 1 of the following year. Any assets remaining on that date shall be handled as described above.

#### Resolution 3 - Omitting Dollar Amounts for Annual Dues and Nomination Fees
